<p>Project Description: The purpose of the proposed project is to drill a borehole approximately 50-100 m deep on the summit of Mt. Granger to permit long term monitoring of changes in temperatures within permafrost. The proposed drilling will occur late September 2008 while the weather and permafrost monitoring stations will remain at the site long term.</p> <p>Project activities include:</p> <ul style="list-style-type: none"> - sling heli-portable drill rig from Mt. Sima to and from site using 5-6 lifts; - drill borehole approximately 50-100 m deep and case hole with PVC tubing over a period of seven days; - install a small climate station, cable and datalogger to monitor permafrost in borehole; - if required, restore ground surface during the summer of 2009; - site visits as required for maintenance and; - if removal is required, dig down to bottom of the active layer, cut and remove tubing, backfill area and remove weather station.

Where conditions permit, the helicopter is to remain 600 m above ground level over caribou, sheep and other wildlife, except during takeoff and landing. 2. Where conditions permit, helicopter activity shall be avoided within one (1) km of sheep or caribou activity. <p><u>Yukon Government varies by adding the following condition:</u></p> <p>The Proponent shall, at least 10 days in advance of the project activities, contact Yukon Government Department of Environment to confirm the proposed timing of activities, including a flight plan/schedule, such that sheep hunting permit holders can be notified of the activities to avoid potential land use conflicts.</p> <p><u>Justification:</u></p> <p>Two thinhorn sheep hunting permits are issued annually to Yukon residents in this area. To prevent potential negative impacts to other users in the area, sheep permit holders should be contacted about proponent's activities.</p>
