

# Information Bulletin:

## Approvals required for a camp or lodge sewage disposal system

*Reviewed and Approved by the Directors' Committee established under the Inter-departmental Waters Agreement for the administration of the Waters Act*

### Purpose

The *Waters Regulation (Waters Act)*, and the *Sewage Disposal Systems Regulation (Public Health and Safety Act)* set out how camp and lodge operators must handle waste, including sewage disposal systems. A sewage disposal system is defined as a system consisting of one or more septic tanks and a soil absorption system, or other system of sewage treatment, disposal or storage

This information bulletin is intended to clarify when a facility will require either a water licence or a sewage disposal permit(s). It does not deal with other aspects of your facility's direct and indirect water use, which might also require a water licence.

## Relevant Legislation

### ***Public Health and Safety Act***

The [\*Sewage Disposal Systems Regulation\*](#) applies to “the disposal of sewage from all buildings and like structures, temporary or permanent, vehicles which have toilet facilities, and sewage produced from public gatherings and campgrounds, except where disposed of by way of a municipal sewer system or as authorized under the *Waters Act*” (*section 3*). It defines sewage as “waste water, human sullage or waste of a like nature contained in or discharging from kitchen, bathing, toilet, laundry facilities or other similar facilities, or a privy.”

### ***Waters Act***

The [\*Waters Act\*](#) prohibits persons from depositing a waste except in accordance with the conditions of a licence or as authorized by regulation (*section 7*). Schedule 8 of the [\*Waters Regulation\*](#) outlines the criteria for a deposit of waste by a camp or lodge which are permitted without a licence (Column 2) or require a type “B” water licence (Column 3).
