## **Additional Information Regarding the Regulation of Oil and Gas Production and Exploration in Yukon**

Updated February 16, 2009

Oil and Gas companies are advised to make themselves aware of legislation and other documents that will affect how oil and gas activity (as defined in the *Oil and Gas Act*) are conducted in Yukon. As this is a non-exhaustive list, it is the responsibility of proponents to meet the requirements of the laws of Yukon in relation to oil and gas activity and operations.

Proponents of oil and gas activity in Yukon must comply with two mandatory application processes.

Licences related to oil and gas activity are issued through the authority of the Chief Operations Officer (COO), of Oil and Gas Resources (OGR). Proponents must satisfy requirements established by the *Oil and Gas Act* (Act).

In tandem with the OGR application process, proponents must also prepare and submit a separate application according to the *Yukon Environmental and Socio-Economic Assessment Act* (YESAA). On November 28<sup>th</sup> 2005, YESAA replaced Yukon's *Environmental Assessment Act* (EAA) and the *Canadian Environmental Assessment Act* (CEAA). ### **1. *Oil and Gas Act*: Licensing of oil and gas activities**

Section 64 of the Act prohibits the carrying out of any oil and gas activity except under the authority of a licence issued by the COO under the Act. Currently, oil and gas activities are governed by the following Yukon legislation:

- *Oil and Gas Act*. Part 3 (Oil and Gas Operations) and relevant provisions in Parts 1 and 4.
- *Oil and Gas Geoscience Exploration Regulations* governing Geoscience Exploration Licences and geophysical, geological and test hole operations.
- *Oil and Gas Drilling and Production Regulations* governing Well Licences and drilling, production and well-related operations, and Field Facility Licences and operations related to field facilities (as defined).
- *Oil and Gas Licence Administration Regulations* which contain provisions applicable to all licences and oil and gas activities.

## **2. Oil and Gas Act: Opportunities for Business Benefit Agreements Respecting Employment and Training**

Section 68 of Yukon's *Oil and Gas Act* states that no oil and gas activity shall be carried out under the authority of a licence unless a benefit opportunities agreement is then in effect. A benefit opportunities agreement is required to contain undertakings by the licensee to provide to the Yukon First Nation and its citizens, residents of communities affected by the activity, and other Yukon residents, opportunities for employment and training, and opportunities to supply goods and services to the licensee and its contractors, through any means or structures that are appropriate in the circumstances.

## **3. Other legislation affecting oil and gas activities, including environmental and socio-economic impacts, surface access and resource management**
